

MARITAL SETTLEMENT AGREEMENT

Sofia Reyes and Marcus Reyes

This Agreement is made on July 20, 2026 between Sofia Reyes, residing at 14 Cedar Court, Apt 2B, New Brunswick, NJ 08901, and Marcus Reyes, residing at 88 Livingston Ave, Highland Park, NJ 08904.

The parties were married on June 16, 2018 and separated on January 10, 2026. A divorce action has been or will shortly be commenced in the Superior Court of New Jersey, Chancery Division — Family Part, Middlesex County. The parties intend this Agreement to be incorporated into, but not merged with, any Judgment of Divorce.

I. SEPARATION

The parties shall live separate and apart, free from interference, authority and control by the other.

II. DIVISION OF PROPERTY

Vehicles: Each of us keeps the vehicle titled in our name. Bank accounts: Our joint Provident Bank checking account will be closed and the balance divided equally between us by September 1, 2026. After that, each of us keeps the accounts in our own name. Retirement accounts: Each keeps their own. Personal property: the parties have already divided their furniture and personal belongings to their mutual satisfaction.

III. DEBTS

The joint Chase credit card will be paid off in full from the joint checking account before that account is closed. After that, each of us is responsible for the debts in our own name. There are no other shared debts. Each party is responsible for the debts in their own name.

IV. ALIMONY

We both agree: neither of us will pay the other alimony (mutual waiver). Each party signs this waiver knowingly and voluntarily, acknowledging that they understand they may be giving up rights and have had the opportunity to consult independent counsel.

V. HEALTH INSURANCE

Sofia currently covers both of us on her Horizon Blue Cross Blue Shield group plan through her employer, Rutgers University. Marcus will obtain his own health coverage within 60 days of the judgment of divorce, and Sofia will keep her employer plan.

VI. NAME

Sofia Reyes shall be restored to the prior name Sofia Delgado.

VII. GENERAL

This Agreement is the entire agreement between the parties. Each signs it voluntarily. Each believes it fair and reasonable. Each acknowledges having had the right to consult independent counsel. It is intended to be incorporated but not merged into the Judgment of Divorce, is governed by New Jersey law, and binds the parties' heirs and assigns.

The parties have signed this Agreement on the date first written above, each before a notary public.
